<i>Banbury R.D.</i> Parishes of: Tadmarton	B.R. 12 (Part)	Amend line of bridle road on draft map to start at the village street and pass east of Camp Farm, and amend statement.
Wroxton	F.P. 4 (Part)	Amend line of footpath on draft map to start in the lane south of the main Abbey gates, and amend statement.
<i>Bullington R.D.</i> Parishes of: Lewknor	F.P. 12 & 12a F.P. 19	Amend line on draft map so that the footpath leaves the Icknield Way at the same point as No. 12 passes along the sunken road between Aston Wood and Little London Wood and then turns southwards to the Nettlebed—Stokenchurch road, and amend statement. Amend line on draft map so that the footpath leaves the Nettlebed—Stokenchurch road at the south western corner of Grant's Plantation, passes between Hailey Wood and Sadler's Wood and then runs to the Buckinghamshire County boundary at Highfield Shaw, and amend statement.
Littlemore	F.P. 7 (Part)	Amend to No. 7 the branch footpath running from the south-western corner of the school playing field to footpath No. 3 south of the railway, now No. 10 on the draft map, and amend statement.
Stadhampton	F.P. 10 (Part)	Amend line of footpath on draft map eastwards to pass along Mill Lane and amend statement.
Stanton St. John	F.P. 8	Amend line of footpath on draft map eastwards to the route admitted by landowner under the Rights of Way Act, 1932.
Waterperry	F.P. 11 (Part)	Amend line of footpath on draft map so that it runs from the north side of Waterperry Post Office, and amend statement.
Watlington	F.P. 13 (Part)	Amend line of footpath on draft map so that from a point approx. 400 yards south-west of Lamp Farm to a point where it turns south-eastwards, the footpath passes along the western side of the field boundary.

Milton-under-Wychwood ...	F.P. 14 (Part)	Amend line of footpath on draft map to pass through Lower Farm at the Milton-under-Wychwood-Burford road end.
