said Committee: Now, therefore, Her Majesty, in pursuance of all powers enabling Her in that behalf, is pleased to appoint and hereby appoints as Members of the said Committee the Lord President of the Council, the Secretary of State for the Home Department, the Secretary of State for the Home Department, the Secretary of State for the Colonies, the Secretary of State for Scotland, the Minister of Health and the Minister of Labour and National Service respec-tively for the time being

And, further, Her Majesty is pleased to reaffirm, in accordance with the provisions of the Order of the 11th day of March, 1920, that during Her Majesty's pleasure the Minister of Health shall pre-side over the said Committee in the absence of the Lord President and that the Secretary of the Medical Research Council for the time being shall act as Secretary of the said Committee.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 11th day of August, 1955, in the words and figures following, that is to say: "We, the Church Commissioners, acting in pur-suance of the Pastoral Reorganisation Measure, 1949, the Union of Benefices Measures, 1923 to 1952, and the Diocesan Stipends Fund Measure, 1953, now humbly lay before Your Majesty in Council the folthe Diocesan Stipends Fund Measure, 1953, now humbly lay before Your Majesty in Council the fol-lowing Scheme which we have prepared with the consent of the Right Reverend Neville, Bishop of Coventry (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Hampton Lucy and the benefice of Charlecote both situate in the diocese of Coventry.

" SCHEME.

"1. Union of Benefices. The benefice of Hampton Lucy and the benefice of Charlecote shall be permanently united together and form one benefice with of Hampton Lucy with Charlecote', but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Edward Reuben Wallace, if he is then incumbent of the said benefice of Hampton Lucy, shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice. first incumbent of the united benefice.

"3. Parsonage House. Upon the union taking effect, the parsonage house at present belonging to the benefice of Charlecote shall be the house of residence of the incumbent of the united benefice, and the parsonage house at present belonging to the and the parsonage house at present belonging to the benefice of Hampton Lucy and the site and appur-tenances thereof and the grounds heretofore usually occupied and enjoyed therewith, with the exception of approximately 2,800 square yards of land situated to the north and west of the stables, shall, as soon as conveniently may be, be sold and disposed of by us, at such time or times and in such manner in all respects as to us shall seem expedient, and the net proceeds of such sale or sales shall constitute and form part of the Expenses Fund of the diocese of Coventry. Coventry.

" 4. Diversion of endowment income.

"(1) Upon the union taking effect a part of the endowment income (calculated in accordance with the schedule hereto) of the united benefice shall be diverted and shall be paid to and be held by us for the benefit of the diocesan stipends fund of the diocese of Coventry, and the amount of the part to be so diverted shall be

- "(a) during the incumbency of the united benefice by the said Reverend Edward Reuben Wallace,—the surplus calculated by us for the twelve months to the 31st March in each year of the said endowment income over and above
- an annual sum of £1,022, and "(b) after the vacation of the united benefice by the said Reverend Edward Reuben Wallace, a fixed annual sum of £680.

"(2) The said endowment income and the said surplus and the said annual sums of £1,022 and £680 shall be deemed to accrue from day to day and shall when we deem that circumstances so require be apportionable accordingly.

"(3) Any moneys due to us from the incumbent of the united benefice, or, during any vacancy in the united benefice, from the sequestrators thereof, as the case may be (hereinafter called 'the incumbent or sequestrators') upon the calculation of the amount to be diverted shall be paid by the incumbent or sequestrators to us not later than the 30th June in
