

by the patrons of the two benefices alternately, the patron of the benefice of Oxhill having the first presentation to the united benefice to be made after the union.

"3. *Union of the benefices of Honington with Idlicote and Whatcote.*

"(1) The benefice of Honington with Idlicote and the benefice of Whatcote separated as hereinbefore provided shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Honington with Idlicote and Whatcote', but the parishes of the said benefices shall continue in all respects distinct.

"(2) If upon the taking effect of the disunion referred to in clause 1 of this Scheme the benefice of Honington with Idlicote shall be vacant, the union shall thereupon take effect, but if it shall then be full the union shall take effect immediately upon the next vacation thereof.

"(3) Upon the union taking effect the parsonage house at present belonging to the benefice of Honington with Idlicote shall, if at that date it so belongs, be the house of residence of the incumbent of the united benefice.

"(4) After the union has taken effect, in every series of five successive turns of presentation or nomination to be made to the united benefice, that one of the alternate patrons of the benefice of Honington with Idlicote who did not make the last presentation to that benefice shall have the first turn, the patron of the benefice of Whatcote shall have the second and fifth turns and the other alternate patron of the benefice of Honington with Idlicote shall have the third and fourth turns."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 11th day of August, 1955, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Bleadon; Uphill; Saint Paul, Weston-super-Mare, and Saint Saviour, Weston-super-Mare, in the diocese of Bath and Wells and for altering the boundaries of the said parishes of Bleadon and Saint Saviour, Weston-super-Mare.

"SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in Part I of the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish and that a suitable endowment therefor will be provided and that it is desirable that the boundaries of the parishes of Bleadon and Saint Saviour, Weston-super-Mare, should be altered in the manner described in Part II of the said Schedule:

"And whereas we have not approved any consecrated church within the area described in Part I of the said Schedule as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend William, Bishop of Bath and Wells (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

"1.—(a) As from the date of the licence thereto of a Minister the area defined in Part I of the said Schedule and delineated on the map hereto

annexed shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Andrew, Bournville, Weston-super-Mare'.

"(d) The parish shall be in the Archdeaconry of Wells and in the rural deanery of Axbridge-Locking District.

"2. As from the date of the publication in the London Gazette of any Order of Your Majesty in Council confirming this Scheme the boundaries of the said parishes of Bleadon and Saint Saviour, Weston-super-Mare, shall be altered in the manner described in Part II of the said Schedule and as delineated on the map hereto annexed.

"THE SCHEDULE.

"PART I.

"The area comprising:—

"All those contiguous parts (together coloured pink on the map annexed hereto) of the parishes of Bleadon; Uphill; Saint Paul, Weston-super-Mare, and Saint Saviour, Weston-super-Mare, which are bounded on part of the north by the territory hereinafter proposed to be annexed to the parish of Saint Saviour, Weston-super-Mare, on the east by the parish of Hutton and on the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of Hutton from the parish of Bleadon opposite the northeastern end of the wall or fence forming the southern boundary of close number 875 and continuing thence southwestwards to and along the last mentioned wall or fence and thence along the middle of the drain forming the southern boundary of closes numbered 876 and 877 to the wall or fence forming the eastern boundary of close number 919 and continuing thence northwards along the last mentioned wall or fence to the wall or fence forming the southern boundary of close number 878 and continuing thence westwards along the last mentioned wall or fence and along the walls or fences forming the southern boundary of closes numbered 880, 918 and 914 and continuing thence westwards in a straight line to a point in the middle of the Weston Loop Line of British Railways (Western Region) (thereby crossing closes numbered 913 and 912 and the Bristol and Exeter Line of British Railways) and continuing thence northwestwards along the middle of the Weston Loop Line of British Railways to a point in the middle of the bridge which carries Drove Road over the last mentioned railway line and continuing thence northeastwards along the middle of Drove Road to a point opposite the western end of the wall or fence forming the northern boundary of the fourth house and premises on the eastern side of Drove Road north of The Ancaster Hotel which stands at the corner of Amberey Road and continuing thence eastwards to and along the last mentioned wall or fence and along the wall or fence on the northern side of the passage way at the rear of the houses and premises on the northern side of Amberey Road and continuing thence in a straight line to a point opposite the middle of the western end of the drain which divides close number 2941 from close number 2927 on the boundary which divides the parish of Saint Saviour, Weston-super-Mare, from the parish of Bleadon.

"PART II.

"The territory to be annexed to the parish of Saint Saviour, Weston-super-Mare, comprising:—

"All that part (coloured blue on the map annexed hereto) of the parish of Bleadon which lies to the north of an imaginary line commencing at a point on the boundary which divides the parish of Hutton from the parish of Bleadon in the middle of Old Junction Road and continuing thence northwestwards along the middle of the last named road to a point opposite the middle of the eastern end of the drain which divides close number 2941 from close number 2927 on the map and continuing thence westwards to and along the middle of the last mentioned drain to its junction with Uphill Great Rhyne on the boundary which divides the parish of Bleadon from the parish of Saint Saviour, Weston-super-Mare."
