The Live Poultry (Mid-Lancashire) (Amendment) Order, 1955.

(Made 28th November, 1955.)

This Order, which came into operation on 28th November, 1955, enlarges the area described in the Live Poultry (Mid-Lancashire) Order, which prohibits the movement of poultry into, out of or within the area.

Holland Elloe Court of Sewers.

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has now confirmed the Order made on the 26th October, 1955, in relation to the Scheme prepared by the Nene River Board under Section 4 (1) (b) of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, making provision for the abolition of the Holland Elloe Court (otherwise known as "the Commissioners of Sewers for the Spalding Court" or "the Spalding Court (Holland Elloe)") of the Commissioners of Sewers for the County of Lincoln, City of Lincoln and County of the said City, and part of the County of Nottingham.

A copy of the Order may be seen at all reasonable hours at the Office of the Clerk to the Nene River Board, North Street, Oundle, Peterborough, and also at the Office of the Ministry of Agriculture, Fisheries and Food, Someries House, St. Andrew's Place, Regent's Park, London, N.W.1.

By Part III of the Second Schedule to the Land Drainage Act, 1930, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
