(c) to provide for the stopping up of (i) a length of the superseded Trunk Road from its northern junction with the route of the new trunk road in a southerly direction for a distance of approxi-mately 130 yards; (ii) a further length of the superseded Trunk Road from its southern junction with the route of the new trunk road in a northeasterly direction for a distance of approximately 210 yards; (iii) that part of Shotton Lane which forms its junction with the eastern side of the route of the new trunk road;

(d) that the Council of the County of Durham will become the highway authority for the new road on the date on which notice is given by the Minister to the Council that the new road is opened for through traffic.
