WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council Scheme bearing date the 21st day of December, 1955, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint Philip, Litherland, and Saint John and Saint James, Litherland, both in and Saint John and Saint James, Litherland, both in the diocese of Liverpool.

" SCHEME.

"Whereas we are satisfied that it is desirable that

whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Clifford, Bishop of Liverpool, consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Church Commissioners have blue the said church and provide the first threatment and threatm

Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Philip, Litherland, and Saint John and Saint James, Litherland, shall be altered in the manner described in the Schedule and delignated on the man appared to this Scheme lineated on the map annexed to this Scheme.

"THE SCHEDULE.

"The territory to be annexed to the parish of St. John and St. James, Litherland, being:—

"All that part of the parish of Saint Philip, Litherland, which is bounded upon the northeast by the parish of Saint John the Evangelist, Walton on the Hill upon the south and southwest by the parish of Saint John and Saint James, Litherland, and upon the remaining side by an imaginary line panish of Saint John and Saint James, Litherland, and upon the remaining side by an imaginary line commencing at a point on the boundary which divides the panish of Saint John and Saint James, Litherland, from the panish of Saint Philip, Litherland, opposite the middle of the southwestern end of Park Lane and proceeding thence northeast wards to and along the middle of the last mentioned lane to the boundary which divides the parish of Saint Philip, Litherland, from the parish of Sefton."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.

"And whereas the Right Honourable David Patrick Maxwell, Viscount Kilmuir, now Lord High Chancellor of Great Britain, acting on behalf of Your Majesty desires to transfer Your Majesty's interest in the advowson of the said benefice to the Bishop of Norwich for the time being and is consenting to this Scheme (in testimony whereof he has executed the same):
