And whereas difficulties having arisen over the provision of accommodation for a physical training instructor at the School the Governing Body have sought to acquire a dwellinghouse in the neighbour-hood of the School which would provide suitable accommodation for such instructor

And whereas the Governing Body in furtherance of such intent did on the 13th day of September, 1955, enter into an Agreement with William Geoffrey Whittingham (conditional on the sanction of Her Majesty in Council being first had and obtained) to purchase for the sum of Two thousand four hundred and fifty pounds a freehold messuage or dwellinghouse known as Hillcrest No 38 Westlands Road (being the dwellinghouse more particularly described in the Schedule to these presents) which said property is coloured orange hatched black on the plan hereto annexed

And whereas the purchase of the said dwelling-house is very desirable in the interests of the School for the reasons hereinbefore appearing

And whereas it is apprehended that the Governing Body have not power under the original Scheme or the said Amending Schemes to acquire the land and property described in the Schedule hereto
