

## TOWN AND COUNTRY PLANNING ACT, 1947.

WESTMORLAND COUNTY COUNCIL.

*County Council of Westmorland Development Plan Amendment No. 1 (1956) Kendal Town Map.*

NOTICE is hereby given that on the 19th day of January, 1956, the Minister of Housing and Local Government amended the above Development Plan.

A certified copy of the Development Plan as amended by the Minister has been deposited at the County Hall, Kendal, and at the Town Clerk's Office, Kendal.

The copies of the Development Plan so deposited will be open for inspection free of charge by all persons interested between the hours of 9 a.m. and 5 p.m. on weekdays except Saturday and 9 a.m. and 12 noon on Saturdays.

The amendment became operative as from the 3rd day of February, 1956, but if any person aggrieved by it desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act, 1947, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment, he may, within six weeks from the 3rd day of February, 1956, make application to the High Court.

## TOWN AND COUNTRY PLANNING ACT, 1947.

HERTFORDSHIRE COUNTY COUNCIL.

NOTICE is hereby given that the Hertfordshire County Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order, 1950, and all other powers enabling them in that behalf have given a Direction entitled the Hertfordshire County Council (Town and Country Planning) (Direction restricting permitted development) No. 2 Order, 1955, and dated the 17th November, 1955 (hereinafter called "the said Direction") directing that permission granted by Article 3 of the Town and Country Planning General Development Order, 1950, shall not apply to any development specified in the First Schedule hereto in the areas specified in the Second Schedule hereto.

The said Direction was approved by the Minister of Housing and Local Government on the 17th December, 1955, and will come into force on the 3rd February, 1956.

A copy of the said Direction and of a map defining the areas to which it relates may be seen at all reasonable hours at the office of the undersigned or at the offices of the Rickmansworth Urban District Council, Rickmansworth, and the Chorleywood Urban District Council, Chorleywood House, Chorleywood.

## FIRST SCHEDULE.

The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture, other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings.

## SECOND SCHEDULE.

The area of land known as the Chess Valley in the north of the Rickmansworth Urban District and the east of the Chorleywood Urban District as shown on the plan attached to the above Order.

STREET TRADING.*Confirmation of Byelaws.*

NOTICE is hereby given that the Council of the Metropolitan Borough of Lewisham intend after the expiration of one calendar month from the 3rd day

of February, 1956, to apply to the Secretary of State for confirmation of byelaws made by them, at their meeting on the 1st February, 1956, under section 27 of the London County Council (General Powers) Act, 1947, prescribing the amount of charges which the Council are authorised to make under section 26 of the Act for the removal of refuse or other services rendered by them and in respect of expenses incurred by them in the administration of Part IV of the Act and in the cleansing of the streets in which street trading takes place and prescribing the fee which the Council are authorised to charge under section 23 of the Act to an applicant for a temporary licence.

BRAUGHING RURAL DISTRICT COUNCIL.

*Braughing Rural District Council Buntingford Footpath Diversion Order, 1955.*

NOTICE is hereby given that on the 25th day of January, 1956, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order will be to create a public right of way on foot and on horseback at Alswick Hall Farm, Buntingford, from a point near the S.W. corner of parcel No. 175 for a distance of approximately 50 yards east and north eastwards for a distance of approximately 350 yards and then north to a point near the S.W. corner of Beauchamps Plantation. To extinguish the public right of way running from a point near the S.W. corner of parcel 175 north-eastwards and north to a point near the S.W. corner of Beauchamps Plantation.

That part of the existing footpath to be extinguished pursuant to the making of this Order shall be deemed to be closed at the expiration of one month from the date of the confirmation of this Order.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Offices of the Council, 2, Hockerill Street, Bishop's Stortford, and will be open for inspection free of charge between the hours of 9 a.m. and 5 p.m.

The Order becomes operative as from the 3rd day of February, 1956, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order, he may, with six weeks from the date of publication of this notice, make application to the High Court.
