**DISEASES OF ANIMALS ACT, 1950.**

Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland acting jointly have made the following Orders:—

**Statutory Instruments 1956 No. 170.**

*The Live Poultry (South Wales and South West England) (Revocation) Order, 1956 (made 13th February, 1956).*

This Order, which came into operation on 14th February, 1956, revokes two Orders which prohibited the movement of poultry into, out of or within a specified area of South Wales and South West England.

**Statutory Instruments 1956 No. 171.**

*The Live Poultry (Essex) (Amendment No. 2) Order, 1956 (made 13th February, 1956).*

This Order, which came into operation on 14th February, 1956, reduces the area described in the Live Poultry (Essex) Order, 1955, which prohibits the movement of poultry into, out of or within the area.

**Statutory Instruments 1956 No. 172.**

*The Live Poultry (Mid-Norfolk) (Revocation) Order, 1956 (made 13th February, 1956).*

This Order, which came into operation on 14th February, 1956, revokes two Orders which prohibited the movement of poultry into, out of or within a specified area of Norfolk and East Suffolk.
