On the evening of 27th October, 1955, Marine Coughtrey was a member of a patrol in Limassol, Cyprus. The patrol chased two men on bicycles who had fled when challenged and concealed themselves in a wooden hut. When the patrol approached, the men inside fired at them and threw a grenade. Although he was armed with only a baton, Marine Coughtrey went into the hut and after a short struggle seized one of the men and threw him outside. He then returned and seized the other man. Marine Coughtrey's courage and disregard for his own safety in entering the hut and tackling the armed men led to the capture of the two terrorists, one of whom was a known criminal.
