The QUEEN has been graciously pleased to give orders for the following appointment to the Most Excellent Order of the British Empire, in recognition of an act of gallantry in Cyprus:—

To be an Additional Member of the Military Division of the said Most Excellent Order:—

Second Lieutenant Michael Edmund BUCKLEY (442034), The Royal Norfolk Regiment.

On 21st March, 1956, 2nd Lieutenant BUCKLEY was in command of the Guard Platoon at Government House. At about 11.50 a.m. he was called to the Governor's bedroom, where what was thought to be a time bomb had been found in the Governor's bed.

On entering the bedroom he confirmed that the object was a time bomb. He asked for a shovel and carried the bomb, on it, out of the house and put it in a sandbagged weapon pit, where it exploded a few minutes later. The bomb was in a very dangerous state and might have exploded at any moment, when once disturbed.

The calm and gallant way in which this young officer handled the difficult and dangerous situation with which he was faced deserves the highest praise.
