UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

A Statute made by the University of Oxford on the 12th June, 1956, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act, 1923.

The Additional Import Duties (No. 2) Order, 1956.

This Order reduces the rate of duty chargeable on Madder root under the Import Duties Act, 1932, from 1s. 3d. per lb to 10 per cent. ad valorem.

The Order comes into operation on the 28th June, 1956, and has been published as Statutory Instruments 1956 No. 950.
