PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 16th day of August, 1956, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Saint Peter, Aintree in the diocese of Liverpool.

" SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting

hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas there is within the said area a consecrated church known as Saint Giles, Aintree which has been approved by us, the said Church Commissioners, as suitable to be the parish church of the new parish and of which the patronage belongs to the Bishop of Liverpool by virtue of an agreement in writing dated the 4th day of February, 1956, and made pursuant to section 9 of the New Parishes Measure, 1943: Measure, 1943:

"Now, therefore, with the consent of the Right Reverend Clifford, Bishop of Liverpool (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners do humbly recommend and propose as follows, that is to say:—

"1. Constitution.

"(a) As from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council confirming this Scheme, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a

mew parish.

"(b) The church of Saint Giles, Aintree aforesaid shall be the parish church of the parish.

"(c) The name of the parish shall be 'The Parish of Saint Giles, Aintree'.

"2. Archdeaconry and Rural Deanery
"The parish shall be in the Archdeaconry of
Liverpool and in the rural deanery of Walton.

"THE SCHEDULE.

"The area comprising:—
"All that part (coloured pink on the map annexed hereto) of the parish of Saint Peter, Aintree which lies generally to the northeast of an imaginary line commencing on the boundary which divides the parish of Sefton from the parish of Saint Peter, Aintree in the middle of the Leeds and Liverpool Canal and extending thence gener-

ally southeastwards along the middle of the Leeds and Liverpool Canal to Handcocks' Bridge and thence southeastwards along the middle of Aintree Lane to the boundary which divides the parish of Saint Peter, Aintree from the parish of Saint Chad, Kirkby."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and sub-mission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.
