EXTINGUISHMENT OF A PUBLIC RIGHT OF WAY.

County Council of West Sussex.

Notice is hereby given that the Minister of Housing and Local Government, in exercise of powers conferred upon him by section 23 of the Town and Country Planning Act, 1944, as incorporated with the Town and Country Planning Act, 1947, has made an Order extinguishing the public right of way over part of Kingston Bay Road, Shoreham-by-Sea, with effect from 21st September, 1956.

LOCAL GOVERNMENT ACT, 1933.

COUNTY OF BUCKINGHAM.

Rural Districts of Wing and Winslow.

Parishes of Drayton Parslow, Soulbury, Stewkley and Stoke Hammond.

Alteration of local boundaries consequent upon alteration of watercourses.

Whereas the River Great Ouse Catchment Board have carried out alterations to certain watercourses which form part of the boundary lines of the rural districts of Wing and Winslow and the parishes of Drayton Parslow, Soulbury, Stewkley and Stoke Hammond;

And whereas the said Catchment Board have, in accordance with subsection (1) of section 145 of the Local Government Act, 1933, notified the Minister of Housing and Local Government of the said alterations and the Minister is satisfied that new boundary lines may conveniently be adopted:

Now therefore the Minister of Housing and Local Government in exercise of his powers under subsection (1) of section 145 of the Local Government Act, 1933, hereby declares that the watercourses shown coloured pink on the two maps deposited at the offices of the Minister (which maps are sealed with the official seal of the Minister and marked "Map No. of 1956 relating to the alterations of watercourses in the county of Buckingham" the number "8" or "9" being inserted therein and used in the references to the maps in this notice) shall be substituted for the watercourses respectively shown coloured blue on the said maps as part of the boundary lines of the said rural districts and the said parishes.

Consequent upon the foregoing declaration those parts of the rural districts and of the parishes respectively named in columns 1 and 2 of the schedule hereto which are shown coloured on the maps as specified in column 3 are, by virtue of the operation of subsection (1) of section 145 of the Local Government Act, 1933, now situate in the rural districts and the parishes respectively named in respect of such parts in columns 4 and 5.

The maps deposited at the offices of the Minister of Housing and Local Government, and copies thereof which have been deposited at the offices of the Buckingham County Council, Aylesbury, are open to inspection without payment during ordinary office hours.

TOWN AND COUNTRY PLANNING ACT, 1947.

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under s. 49 of the Town and Country Planning Act, 1947, entitled "The Stopping up of Highways (Surrey) (No. 7) Order, 1956" authorising the stopping up of a length of the footpath leading from Claremont Avenue to West End Lane, Esher, Surrey, and requiring the provision of a new footpath.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning Act, 1947, or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within six weeks of the 21st September, 1956, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
