

Amend the statement annexed to the Draft Map in respect of CRIB.AST.15 to read "from 50514" and not "from FP.AST.7" as at present shown.

*Parish of Stanway.*

*Map No. 11.*—Continue footpath ASY.28 in a northerly direction to join county road as described in the statement annexed to the Draft Map.

*Map No. 25.*—Add footpath from county road B.4077 south east to the county road north of Stumps Cross.

*Map No. 22.*—Add footpath from Salters Lane, proceeding east to parish boundary south of St. Mary's Abbey, Hailes, to provide continuity of footpath ASY.40.

*Map No. 22.*—Add footpath from parish boundary near Cromwells Clump in a northerly direction to join footpath ASY.34 at Wood Stanway.

*Map No. 22.*—Delete CRIB.ASY.43, known as Salters Lane.

*Parish of Stoke Orchard.*

*Map No. 20.*—Alter description of short length of ASO.16 north of Uckington Brake from footpath to bridle road to join county road 60256 with bridle road ASO.26, of which it will form a part and amend the statement annexed to the Draft Map accordingly.

*Parish of Sudeley.*

*Maps Nos. 23 and 24.*—Delete footpath ASU.16 from Belas Knap south east via Humblebee How to the county road near Limefield.

*Parish of Sudeley.*

*Map No. 33.*—Delete part of footpath ASU.22 from its junction with ASU.23 east to Holt Farm, then south to the junction with footpath ASU.21. The remainder of ASU.22 to be incorporated as part of footpath ASU.23 and the statement annexed to the Draft Map amended accordingly.

*Parish of Swindon.*

*Map No. 20.*—Add short length of footpath from ASW.13 north of Swindon Rectory south west to county road north of Swindon Church, to accord with the description contained in the statement annexed to the Draft Map.

*Map No. 20.*—Delete bridle road ASW.9 from county road north west of Home Farm, north west then north-east.

*Map No. 29.*—Delete footpath ASW.15 south east of Swindon Hall east to county road at the parish boundary.

*Map No. 29.*—Delete part of footpath ASW.19 from the county road 3/85 near the Cross Hands Inn, north east to a point east-south-east of Swindon Farm, and amend the statement accordingly.

*Parish of Teddington.*

*Map No. 7.*—Delete footpath ATE.1 from the parish boundary north of Brickyard Cottages east then south to the county road east of Brickyard Cottages.

*Parish of Uckington.*

*Map No. 19.*—Delete part of footpath AUC.10 from the county road near Manor Farm south west to the junction with footpath AUC.11 south west of Old Hall. The remainder of AUC.10 to be incorporated in footpath AUC.11 and the statement annexed to the Draft Map to be amended accordingly.

*Map No. 19.*—Delete footpath AUC.13 from AUC.10 east to bridle road AUC.14 south of Old Hall, Uckington.

*Parish of Winchcombe.*

*Map No. 23.*—Add footpath from the county road 50520 north of Woodbine Cottages south to the parish boundary in Breakheart Plantation to join new footpath in Southam parish which leads on to Cleeve Common.

*Map No. 23.*—Add footpath from Postlip Mills in a general south easterly direction via Corndean Farm to Corndean Hall, then east to the county road.

*Map No. 21.*—Add footpath from AWB.11 west of Warren Lodge, south west to Parish boundary south west of Warren Lodge.

*Map No. 22.*—Add footpath from Haile Street, Winchcombe to Silk Mill, Winchcombe, known locally as "Murder Alley".

*Map No. 23.*—Realign part of spur footpath AWB.24 into O.S. No. 221 and not 223 as at present

shown. The whole of the spur to be renumbered to form a continuation of footpath AWB.31 and the statement annexed to the Draft Map to be amended accordingly.

*Map No. 23.*—Realign part of footpath AWB.31 from Corndean Farm east to its junction with AWB.24, to be shown in O.S. 162 and not 161 as at present shown.

*Map No. 23.*—Realign the southern half of footpath AWB.33 to follow a line adjacent to the parish boundary east of and parallel to the present position until it reaches Belas Knap.

*Map No. 23.*—Delete part of footpath AWB.31 east of its junction with AWB.24.

*Map No. 23.*—Delete footpath AWB.32 from Postlip Mills south to bridle road AWB.21 south of Postlip Mills.

*Parish of Woodmancote.*

*Map No. 23.*—Add footpath from Gambol's Lane, east of Bottomley Farm, north to join footpath AWO.21 east of Bottomley Farm.

*Map No. 20.*—Realign footpath AWO.1 along the side of Kayte Lane to accord with the Diversion Order of 1940.

*Map No. 23.*—Continue bridle road AWO.25 in a northerly direction to join county road No. 40360 to accord with the description contained in the statement annexed to the Draft Map.

*Map No. 23.*—Delete footpath AWO.17 from county road at Home Farm north to footpath AWO.14, south east of Yew Tree Farm.

IN THE RURAL DISTRICT OF NORTH COTSWOLD.

*Parish of Guiting Power.*

*Maps Nos. 22 and 29.*—Add footpath from route 3/99 opposite the Chapel, Guiting Power, in a southerly direction across the green to join route 40622 north of the Vicarage.

IN THE RURAL DISTRICT OF NORTHLEACH.

*Parish of Northleach with Eastington.*

*Map No. 16.*—Add footpath in the village of Eastington to join county road 50871 with county road 50872.

*Parish of Chedworth.*

*Map No. 21.*—Realign footpath KCH.66 at the north eastern end such that it joins the county road No. 40879 at a point approximately 70 yards south east of the present position.

IN THE RURAL DISTRICT OF SODBURY.

*Parish of Alderley.*

*Map No. 5.*—Amend Draft Map and statement for footpath LAL.2, to include a short spur north east to the parish boundary to join Wotton-under-Edge footpath CWE.80.

*Parish of Cold Ashton.*

*Map No. 31.*—Reclassify LCA.16 from footpath to bridle road from LDN.46 to Freezinghill Lane.

*Maps Nos. 31 and 32.*—Delete footpath LCA.14 from Freezinghill Lane opposite Toghill House Farm, south east to footpath LCA.15 at Greenway Lane.

*Maps Nos. 32 and 31.*—Delete footpath LCA.24 from ORB.LCA.38, Hall Lane, north to its junction with footpath LCA.35 south of Hill Farm.

*Maps Nos. 31 and 32.*—Delete footpath LCA.25 from footpath LCA.15 east of Hamswell House to footpath LCA.24 south of Hill Farm.

*Parish of Dodington.*

*Map No. 24.*—Realign footpath LDO.32 along the eastern and northern boundaries of O.S. No. 223.

Amend statement annexed to the Draft Map in respect of bridle road LDO.26 to include the words "No right of drift."

*Parish of Dodington.*

*Maps Nos. 15 and 24.*—Delete footpath LDO.10 from route 41986 north east via Down Farm to bridle road LDO.9 near Lyde Farm.

*Map No. 24.*—Delete footpath LDO.21 from county road 3/296 west of Dean and Chapter Farm, Codrington, north east to county road 41996 north of Dean and Chapter Farm, Codrington.
