"2. The territory to be annexed to the parish of Saint Mark, Battersea Rise, comprising:—

"All those contiguous parts (together coloured blue on the said map) of the parishes of Saint Anne, Wandsworth, and Saint Michael, Wandsworth Common, Battersea, which lie to the southeast of the middle of the Waterloo to Wimbledon line of British Railways (Southern Region) to the northeast and north of the wall or fence which forms the southwestern and southern boundary of the premises known as Emanuel School and to the southwest of the middle of the Victoria to Balham line of British Railways (Southern Region).

"3. The territory to be annexed to the parish of Saint Mary, Summers Town, comprising:—

"(a) All that part (coloured green on the said map) of the detached part of the parish of Saint Anne, Wandsworth, which lies to the southwest of an imaginary line commencing on the boundary which divides the detached part of the last-mentioned parish from the parish of Saint Andrew, Earlsfield, at a point opposite the middle of the southeastern end of Dawnay Road and continuing thence in a straight line southeastwards across the grounds of Springfield Hospital, for a distance of 27½ chains or thereabouts, to a point on the boundary which divides the aforesaid detached part of the parish of Saint Anne, Wandsworth, from the parish of Saint Augustine, Tooting, in the middle of the southeastern end of the footpath which runs along the southwestern boundary of close numbered 9344 on the map.

"(b) All that part (coloured purple on the said map) of the parish of Saint Augustine, Tooting, which is bounded on the north-west and southwest by the parish of Saint Mary, Summers Town, and on the northeast and southeast by the grounds of Streatham Cemetery."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Southwark.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of October, 1956, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Worplesdon; Emmanuel Stoughton, Stoke-next-Guildford; Saint Nicholas, Guildford; and Stoke-next-Guildford, all in the diocese of Guildford.

"SCHEME.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Ivor, Bishop of Guildford, consents to the proposed arrangements (in testimony whereof he has executed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Worplesdon; Emmanuel

Stoughton, Stoke-next-Guildford; Saint Nicholas, Guildford; and Stoke-next-Guildford shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"THE SCHEDULE.

"(1) Territory to be annexed to the parish of Stoke-next-Guildford:—

"(a) All that part (coloured pink on the map annexed hereto) of the parish of Emmanuel Stoughton, Stoke-next-Guildford, which lies to the east of the middle of the main railway line of British Railways (Southern Region) and to the north of the middle of the Guildford-Cobham railway line of the said British Railways.

"(b) All that part (coloured green on the map annexed hereto) of the parish of Saint Nicholas, Guildford, which lies to the east of the middle of the said main railway line of British Railways and to the northwest of the boundary dividing the Friary and Stoke wards of the Municipal Borough of Guildford following generally the middle of the said Guildford to Cobham railway line of British Railways.

"(2) Territory to be annexed to the parish of Saint Nicholas, Guildford:—

"All that part (coloured mauve on the map annexed hereto) of the parish of Emmanuel Stoughton, Stoke-next-Guildford, which lies to the southeast of the said Guildford-Cobham railway line of British Railways.

"(3) Territory to be annexed to the parish of Emmanuel Stoughton, Stoke-next-Guildford:—

"All that part (coloured brown on the map annexed hereto) of the parish of Worplesdon which lies within the boundary of the Municipal Borough of Guildford."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Guildford.
