

under (ii) and been released, with full terminal benefits, before completing that period, under special arrangements made by the Air Ministry for those returning from service overseas near the end of their engagement.

No candidate will be eligible for inclusion in this reservation if his whole-time service ceased more than two years before 1st March or 1st September, as the case may be, of the year in which the examination is held (see Regulation 3).

**8. Candidates Trained as Teachers.**

Candidates who have been trained as teachers, elsewhere than in England and Wales, and upon whose training public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Scottish Education Department, the Ministry of Education

for Northern Ireland) has been notified to the Commissioners.

**9. Fee.**

An application fee of 7s. 6d. is payable by all candidates. This must be sent with the application form and is not returnable in any circumstances. A further fee of 12s. 6d., being the balance of the prescribed fee of £1, must be paid by each candidate on admission to the examination.

The Civil Service Commissioners further give notice that an Open Competition will be held under the above Regulations, the written examination commencing on 12th March, 1957.

Applications on the prescribed form for admission to the Competition should be received by the Secretary of the Civil Service Commission on or before 10th January, 1957. Application forms may be obtained from the Secretary at once.

URBAN DISTRICT AND PARISH OF NEWPORT PAGNELL.

RURAL DISTRICT OF NEWPORT PAGNELL AND PARISHES OF CHICHELEY AND NORTH CRAWLEY.

*Alteration of local boundaries consequent upon alteration of watercourses.*

Whereas the watercourse between the points marked "A" and "B" on the map deposited at the offices of the Ministry of Housing and Local Government, sealed with the official seal of the Minister, marked "Map No. 12 of 1956 relating to the alteration of watercourses in the county of Buckingham" and in the Schedule hereto referred to as "Map 12" forms part of the boundary line between the urban district and parish of Newport Pagnell and the rural district of Newport Pagnell and the parish of Chicheley in the county of Buckingham and of the boundary line between the said parish of Chicheley and the parish of North Crawley in the said rural district and county;

And whereas the watercourse between the points marked "C" and "D" on the map deposited and sealed as aforesaid, marked "Map No. 13 of 1956 relating to the alteration of watercourses in the county of Buckingham" and in the said Schedule referred to as "Map 13" forms, for the most part, part of the boundary line between the said urban district and parish of Newport Pagnell and the said rural district of Newport Pagnell and the said parish of Chicheley;

And whereas the River Great Ouse Catchment Board have carried out alterations to portions of the said watercourses and the altered portions are coloured pink on the said maps;

And whereas the said Catchment Board have, in accordance with subsection (1) of section 145 of the Local Government Act, 1933, notified the Minister of the said alterations and the Minister is satisfied that new boundary lines may conveniently be adopted:

Now therefore the Minister of Housing and Local Government in exercise of his powers under subsection (1) of section 145 of the Local Government Act, 1933, hereby declares that the said watercourses as altered shall form parts of the boundary lines between the said county districts and parishes and between the said parishes.

Consequent upon the foregoing declaration and by virtue of the operation of subsection (1) of section 145 of the Local Government Act, 1933, those parts of the areas named in column 1 of the said Schedule which are hatched on the said maps and marked thereon as specified in respect of such areas in column 2 are now situate in the areas so specified in column 3.

The maps deposited at the offices of the Minister of Housing and Local Government and the copies thereof which have been deposited at the offices of the Buckingham County Council, County Hall, Aylesbury, are open to inspection without payment during ordinary office hours.

COUNTY OF ESSEX.

BOROUGHES OF ILFORD AND WANSTEAD AND WOODFORD.

*Alteration of local boundaries consequent upon alteration of watercourse.*

Whereas the River Roding Catchment Board carried out alterations to certain watercourses which form part of the boundary lines between the borough and parish of Ilford and the borough and parishes of Wanstead and Woodford in the county of Essex;

And whereas the functions of the said Catchment Board in respect of the said alterations were transferred to the Essex River Board by the River Boards Act, 1948;

And whereas the said River Board have, in accordance with subsection (1) of section 145 of the Local Government Act, 1933, notified the Minister of Housing and Local Government of the said alterations and the Minister is satisfied that new boundary lines may conveniently be adopted:

Now therefore the Minister of Housing and Local Government in exercise of his powers under subsection (1) of section 145 of the Local Government Act, 1933, hereby declares that the watercourses shown outlined in red on the map deposited at the offices of the Minister (which map is sealed with the official seal of the Minister, marked "Map No. 2 of 1956 relating to the alteration of watercourses in the county of Essex" and hereinafter referred to as the "map") shall be substituted for the watercourses shown coloured blue on the map as part of the boundary lines between the said boroughs and the said parishes.

Consequent upon the foregoing declaration those parts of the boroughs and of the parishes respectively named in columns 1 and 2 of the schedule hereto which are hatched on the map as specified in column 3 are, by virtue
