The QUEEN has been graciously pleased, on the advice of Her Majesty's Canadian Ministers, to approve the award of the George Medal to the undermentioned:—

Henry Martin Clifford JOHNSTONE, Corporal, Royal Canadian Mounted Police.

Four masked armed men held up the Royal Bank of Canada at Coquitlam, B.C. Johnstone responded to the alarm sounded by the bank manager, entered the bank and was immediately felled by a bullet from the revolver of one of the bandits, who rose from behind the counter. Another man appeared at Johnstone's left and fired at him. Johnstone from a prone position on the floor returned the fire of the two men. A third bandit ran from the back of the bank towards the front door and fired at point blank range at Johnstone as he passed him. Johnstone's wounds stopped him momentarily from continuing his fire and the bank robber behind the counter seized this opportunity to escape with his companions. Johnstone, suffering from loss of blood from eight bullet wounds struggled to his feet and followed the men from the bank. He collapsed on the pavement in front of the bank but managed to sit up and cover two of the bandits, who had fallen to the pavement, with his empty service revolver. He had killed one bandit and wounded another. Other police then arrived and took over.
