REGULATIONS FOR THE RECRUITMENT OF BOYS AND GIRLS TO GRADE 6 POSTS IN BRANCH B OF THE FOREIGN SERVICE.

1. The competition is open to boys and girls. Married women are not eligible, and the approval of the Secretary of State is required before a married man takes up appointment.

2. Age. Candidates must be at least 16 and under 18 years of age on 1st September, 1957. But candidates who have served in any established
