EXPLANATORY NOTE.

These Regulations amend those provisions of the National Insurance (Unemployment and Sickness Benefit) Regulations, 1948, which provide for the taking into account, for the purposes of unemployment and sickness benefit, of contributions other than those of the appropriate class; those provisions which prohibit (in the case of an insured person who is following any gainful occupation) a day's being treated as a day of unemployment; those provisions which prescribe, in relation to a female relative of a person entitled to unemployment benefit or sickness benefit, conditions to be fulfilled for the relative of a person entitled to unemployment benefit or sickness benefit, conditions to be fulfilled for the purpose of that person's right to an increase of benefit in respect of her and those provisions which prescribe relatives in respect of one of whom a person entitled to unemployment benefit or sickness benefit may be entitled to an increase of such benefit if the relative is residing with, and is wholly or mainly maintained by, the person so entitled. They also revoke those provisions which prescribe, in relation to a woman having the care of a child of the family of a person entitled to benefit of certain descriptions, conditions to be fulfilled for the purpose of that person's right to an increase of benefit in respect of her.

EXPLANATORY NOTE.
