under the style of 'The United Benefice of Brandon Ferry with Wangford, Santon and Santon Down-ham', but the parishes of the said benefices shall continue in all respects distinct.

- "2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend John Fleetwood Boodle if he is then incumbent of the said benefice of Brandon Ferry with Wangford shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice henefice.
- "3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Brandon Ferry with Wangford shall the house of residence of the incumbent of the united benefice.
- "4. Patronage. In every series of four successive turns of presentation to be made to the united benefice after the union has taken effect the Minister of Agriculture, Fisheries and Food (being one of the patrons of the benefice of Santon with Santon Downham) shall have the first turn, the patrons of the benefice of Brandon Ferry with Wangford shall have the second and fourth turns and the Bishop have the second and fourth turns and the Bishop of Saint Edmundsbury and Ipswich for the time being (being the other patron of the benefice of Santon with Santon Downham) shall have the third
- "5. Provision for a curate or other assistance.
  Upon the union taking effect the incumbent shall, in order to assist him in performing the duties of the united benefice, employ a curate or such other clerical or lay assistance as the Bishop of the said diocese may from time to time direct."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.
