PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the Parish of Hopton St. Margarets, in the County of Suffolk, 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Hopton, in the said County of Suffolk, save with the previous approval of the Minister of Housing and Local Government, should be prohibited and that burials should be discontinued therein as follows, viz.:-

Hopton.—Forthwith and entirely in the Old St. Margarets Churchyard in the said Parish.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 8th day of November next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such representation one month before the said 8th day of November.

The Queen's Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 12th day of September, 1957, in the words and figures following, that is to say:-

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Christ Church, Milton and Ifield both in the diocese of Rochester.

"SCHEME

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Christopher, Bishop of Rochester, consents to the proposed

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Christ Church, Milton and Ifield shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"THE SCHEDULE

"The territory to be annexed to the parish of Christ Church, Milton:-

"All that part (coloured pink on the map annexed hereto) of the parish of Ifield which is bounded on the north by the parish of Christ Church, Milton, and on the remaining sides by a continuous imaginary line commencing on the boundary which divides the last mentioned parish from the parish of Ifield at a point in the middle of Singlewell Road and proceeding thence generally southwards along the middle of the last mentioned road to a point opposite the eastern end of the wall or fence which forms the southern boundary of the house or premises numbered 306 Singlewell Road thence westwards to the last mentioned boundary thence generally southwards along the wall or fence forming the western boundary of Southfields School thence eastwards along the wall or fence forming the southern boundary of the aforesaid school to its end and thence in a straight line eastwards to the western end of the fence which forms the southern boundary of the Kings Farm and Singlewell Housing Estate and thence eastwards along the last mentioned fence and in a straight line in continuation thereof to the middle of Valley Drive and thence northeastwards along the middle of the last mentioned road to the boundary which divides the parish of Ifield from the parish of Christ Church, Milton."

And Whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And Whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.
