

## CLEAN AIR ACT, 1956.

## THE WILLENHALL (No. 1) SMOKE CONTROL ORDER, 1957.

1. NOTICE is hereby given that the Urban District Council of Willenhall in exercise of the powers conferred on them by section 11 of the above-mentioned Act on the 18th day of September, 1957, made an Order entitled the Willenhall (No. 1) Smoke Control Order, 1957, declaring the area described in the Schedule hereto to be a Smoke Control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

2. Subject to the exemptions provided by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Hall, Willenhall, at all reasonable times during the period of six weeks from the 8th day of October, 1957.

4. Within the said period any person who will be affected by the Order may by notice in writing to The Secretary, Ministry of Housing and Local Government, Whitehall, London, S.W.1, object to the confirmation of the Order.

The land and premises comprising the New Invention Housing Estate of the Urban District Council of Willenhall being land and dwelling houses abutting on Cannock Road, Littleton Road, Brereton Road, Lea Croft, Wyrley Close, Sandwell Place, Springhill Close, Mitre Close, Huntington Road, Rugeley Avenue and Forest Gate.

*Alteration of Borough Boundaries.*

## AMERSHAM RURAL DISTRICT (ASHLEY GREEN No. 1) DIVERSION ORDER, 1957.
