SPECIAL ROADS ACT, 1949.

Woodbridge By-pass, Junctions with Bullards Lane and Grundisburgh Road Improvements.

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under section 14 of the Special Roads Act, 1949, the effect of which is:—

(a) to provide for the re-alignment of two lengths of Grundisburgh Road, Woodbridge, in the county of East Suffolk, so as to form a new staggered junction with the London—Great Yarmouth Trunk Road;

(b) to provide for the stopping up of a length of Bullards Lane extending for 38 yards from its junction with the eastern side of the said Trunk Road.
