PUBLIC SCHOOLS ACT, 1868.

THE GOVERNING BODY OF ETON COLLEGE having on the 12th day of October, 1957, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending Statute XX of the existing Statutes of the said College, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE to alter and amend the Statutes of Eton STATUTE to alter and amend the Statutes of Eton College which amending Statute having been duly made at a Meeting held at Eton on the 12th day of October, 1957, of the Provost and Fellows of Eton College (the said Provost and Fellows being the new Governing Body of the said College for the purposes of the Public Schools Act, 1868, and the Acts amending the same) and passed at such Meeting by a majority of votes of the Members present and voting is now submitted for the approval of Her Majesty in Council.

We the Provost and Fellows of Eton College being the new Governing Body of the said College (hereinafter called "the College") for the purposes of the Public Schools Act, 1868, and the Acts amending the same in pursuance of the power given to us by the Eleventh Section of the Public Schools Act, 1868 (and of all other powers us hereunto enabling) to alter the Statutes made under that Act and the Acts amending the same in relation to the College do hereby amend the Statutes of the College in the manner following that is to say: in the manner following that is to say:

By deleting Section (1) of Statute XX and by substituting therefor the following Section:—

"(1) Except as provided for in Section:—
"(1) Except as provided for in Section (3) of this Statute, there shall be such number (not being less than seventy) of Scholars on the Foundation of the College as the Provost and Fellows may from time to time by Resolution determine and in default of any such determination there shall be seventy such Scholars".

PRESENT

The QUEEN's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 30th day of September, 1957 (N.P. 4097/57) in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of service in Your Majesty's Naval or Marine Force to a person being, or having been an Officer, Seaman or Marine therein, or to the widow or any relative of a deceased Officer, Seaman or Marine, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council: in Council:

"And whereas by Orders in Council dated 2nd February, 1937, 9th May, 1940, 17th September, 1942, 22nd July, 1943, and 29th November, 1946, certain improvements were made in the rates of disability retired pay, pensions and allowances payable to or in respect of Officers, Petty Officers, Non-commissioned Officers and Men of Your Majesty's Naval, Marine and Reserve Forces: Marine and Reserve Forces:

"And whereas, with the approval of the Lords Commissioners of Your Majesty's Treasury, payments have been made to pensioners in receipt of disability pensions from the Admiralty, or to the dependants of Naval Officers or ratings, at the same rates, and subject to the same conditions as have been authorised for similar pensioners receiving pensions from the for similar pensioners receiving pensions from the Ministry of Pensions and National Insurance:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the said improvements in the conditions and rates of disability retired pay, pensions and allowances as set out in the annexed Schedules A, B, C and D with effect from the various dates stated therein.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

"SCHEDULE A.

- "RATINGS' DISABLEMENT PENSIONS AND ALLOWANCES.
- "1. Increased rate of disability additions for R.N. ratings and R.M. other ranks.

For the rate of 32s. 6d. (100% disablement addition) a week appearing in Order in Council of 6th February, 1922, Schedule I, Disablement Clause (a), as amended by Orders in Council of 17th September,
