MERSEY TUNNEL JOINT COMMITTEE

REVISION OF TOLLS

NOTICE is hereby given that the Mersey Tunnel Joint Committee has applied to the Minister of Transport and Civil Aviation for his approval (including the making of any necessary Order) in respect of certain proposed amendments and revisions affecting the existing Tolls which the Joint Committee is now authorised to demand, take and recover for the use of the Mersey Tunnel.

The proposals submitted to the Minister provide (inter alia) for the abolition of the charge for passengers carried in private vehicles, a uniform toll for private motor cars and a reduction in the number of toll classifications from 27 to 16. The proposed new tolls are as follows, viz.:-
