For courage and leadership over a long period in action against dissident tribesmen. On one occasion, under close fire, when his company commander was killed, his immediate and successful assumption of command enabled the company successfully to complete its task.

For gallantry on 27th January, 1957, when No. 9 Squadron, of which he was a member, was twice involved in fierce and potentially dangerous engagements with Yemini Army Units. The success achieved was largely due to his actions and example.
