"THE SCHEDULE

"1. Territory to be annexed to the parish of Pannal:

"(a) All that part (coloured pink on the map annexed hereto) of the parish of Kirkby Overblow which lies generally to the north of the boundary of the Borough of Harrogate.

"(b) All that part (coloured green on the map annexed hereto) of the parish of Spofforth which lies generally to the west of the boundary of the Borough of Harrogate and to the southwest of the middle of the Church Fenton and Harrogate line of British Railways (North Eastern Region).

"(c) All that part (coloured yellow on the map annexed hereto) of the parish of Stainburn which lies generally to the north of the boundary of the Borough of Harrogate.

"All that part (coloured brown on the map annexed hereto) of the parish of Pannal which lies generally to the northwest of an imaginary line commencing on the boundary which divides the parish of (Saint Mary) Low Harrogate from the parish of Pannal at a point in the centre of the junction of Lady Lane, Whinny Lane and Hill Top Lane and extending thence southeastwards to and along the middle of Hill Top Lane to a point opposite to the northwestern boundary of close numbered 611 and continuing thence southwestwards to and along the northwestern boundaries of closes numbered 610, 607 and 606 and in continuation thereof in the same straight line to the boundary which divides the parish of Pannal from the parish of Stainburn."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.
