BOARD OF TRADE REGULATIONS—TR. CIRCULAR No. 4.

The Board of Trade announce the following amendment to Tr. Circular No. 4 which is issued to each Trustee on his first appointment under the Bankruptcy Acts:

Paragraph 40. Remittances to Bankruptcy Estates Account.

Delete second paragraph and substitute:

“The remittances to the Bank of England should be accompanied by Remittance Form Tr. 5 and 5b which will be supplied on application to the Inspector General. Halfpence should not be included in remittances.”

PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Power hereby gives notice that, in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, he has renewed for a period of twelve months a prospecting licence, granted to Imperial Chemical Industries Limited, Imperial Chemical House, Millbank, London, S.W.1, in respect of an area of 196 square miles in the county of York.
