REGULATIONS FOR ENFORCING ORDER AT HACKNEY CARRIAGE STANDINGS IN THE CITY OF LONDON.

City Police Headquarters, 26, Old Jewry, E.C.2.

I, the Commissioner of Police for the City of London, by virtue of section 9 of the City of London (Various Powers) Act, 1956, hereby make the following Regulations to be observed by drivers of hackney carriages at all hackney carriage standings within the Oity of London:

1. The drivers of the first two hackney carriages on the standing or on any separate portion of the standing shall at all times be with their hackney carriages and shall be available for hiring im-

2. No driver shall allow his hackney carriage to remain on a standing or any portion of a standing unless he is willing to accept any lawful hiring that may be offered.

3. (i) At Standings where more than one hackney carriage is permitted the second and any subsequent hackney carriage must be positioned as close as possible to the hackney carriage immediately in front of it.

(ii) All drivers must move their hackney carriages up as vacancies occur, and vacancies must not be filled in any other manner.

(iii) When a standing is divided into several portions, the driver of the leading hackney carriage on each portion shall move his hackney carriage to fill any vacancy in the next portion (or in such other portion as may be set out in the Regulations appointing the standing) immediately such vacancy occurs mediately such vacancy occurs.

4. No disabled hackney carriage shall remain on a standing longer than is reasonably necessary to effect its removal, unless such disablement is tem-

porary and is remedied without delay.

5. Drivers must not congregate unnecessarily on, or obstruct, the carriageway or footway, and their behaviour must be such that no annoyance or dis-turbance is caused or is likely to be caused to residents or other persons in the vicinity.

6. The provisions of these regulations are in addition to and not in derogation of the provisions of any regulations applying to particular standings.
