PRESENT.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 22nd day of November, 1957, in the words and figures following, that is

"We, the Church Commissioners, in pursuance of the Church Patronage Act, '1870, and of the Acts therein mentioned, have prepared the following Scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called the said benefice') of Saint Catherine, Bearwood in the County of Berks and in the diocese of Oxford.

"Whereas we are satisfied that John Walter of Saint Catherine's Lodge, Bearwood in the County of Berks, Esquire, is the patron or person entitled to present or nominate to the said benefice:

"And whereas the said John Walter desires to transfer the advowson of the said benefice to the Bishop of Oxford for the time being and is consenting to this Scheme (in testimony whereof he has executed the same):

"And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

"Now, therefore, with the consent of the Right Reverend Harry, Bishop of Oxford (in testimony whereof he has executed this Scheme), we, the said whereof he has executed this Scheme), we, the said Church Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Harry, Bishop of Oxford, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely upon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Oxford for the time being.

And Whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 22nd day of November, 1957, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of All Saints, Oldham; Saint Anne, Longsight, Royton; Coldhurst; Saint Mark, Heyside; and Saint Stephen and All Martyrs, Lower Moor, all in the diocese of Manchester.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned;

" And whereas the Right Reverend William, Bishop of Manchester, consents to the proposed arrange-ments (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of All Saints, Oldham; Saint Anne, Longsight, Royton; Coldhurst; Saint Mark, Heyside; and Saint Stephen and All Martyrs, Lower Moor, shall be altered in the manner described in the Schedule and delineated on the map annexed the Schedule and delineated on the map annexed to this Scheme.

"THE SCHEDULE

"1. The territory to be annexed to the parish of All Saints, Oldham:—

"All that part (coloured pink on the map annexed hereto) of the parish of Saint Anne, Longsight, Royton, which is bounded on the southwest by the parish of All Saints, Oldham, on the southeast by parish of All Saints, Oldham, on the southeast by the parish of Coldhurst and on the remaining sides by an imaginary line commencing on the boundary which divides the parish of Coldhurst from the parish of Saint Anne, Longsight, Royton, in the middle of the footpath which forms the northeastern and eastern boundaries of Westwood Park between West-hulme Avenue and Westhulme Street at the point where the first mentioned boundary turns eastwards where the first mentioned boundary turns eastwards towards Rochdale Road and proceeding thence first northwards then northwestwards along the middle of the said footpath to its end on the eastern side of
