ORDER, 1957.

NOTICE is hereby given that, pursuant to Regulation 4 (1) of the Public Health (Imported Food) Regulations, 1937, as amended by the Public Health (Imported Food) (Amendment No. 2) Regulations, 1948(b) (hereinafter called "the said Regulations"), the Minister of Agriculture, Fisheries and Food on the 16th day of December, 1957, made an Order entitled the Lambeth (Imported Food Regulations) Order, 1957. This Order comes into operation on the 1st day of January, 1958, and requires the Council of the Metropolitan Borough of Lambeth and its officers to undertake the enforcement and execution of the said Regulations within the district of the said Council as if the Lambeth Council were a sanitary authority.

THE BOROUGH OF FOLKESTONE.

COAST PROTECTION ACT, 1949.

*The Folkestone Marine Walk Coast Protection
Works Scheme, 1957.*

THE Mayor Aldermen and Burgesses of the Borough of Folkestone acting in their capacity as coast protection authority hereby give notice under sub-section (1) of section 8 of the above Act that they propose to carry out coast protection work as described herein at Marine Walk, Folkestone, in the county of Kent.

The work will be carried out along the length of coast eastward of the eastern boundary of Palm Beach, Lower Sandgate Road, Folkestone, for a distance of approximately 4,000 feet and will consist of the construction of a new concrete sea wall, the construction of a concrete apron and toe protection to and otherwise strengthening of the existing sea wall where necessary, the laying of drains, the removal and construction of groynes and other works. The estimated cost of the work is £320,000.

A copy of the Scheme and the plan referred to therein have been deposited at the Town Clerk's Office, West Terrace, Folkestone, and may be seen there at all reasonable hours.

Any person may not later than the 24th day of January, 1958, serve a written notice of objection to the above proposal on the Minister of Housing and Local Government and on the above-mentioned authority. Any such notice must contain a statement of the grounds of objection and must be sent by pre-paid post to the Secretary, Ministry of Housing and Local Government, Whitehall, London, S.W.1, and to the Clerk of the Authority at the address shown below.

KESTEVEN (ROADS RESTRICTION) (HALFPENNY
HATCH BRIDGE) ORDER, 1957.

THE County Council of the County of Lincoln, Parts of Kesteven, have applied to the Minister of Transport and Civil Aviation for confirmation of an Order made by them under the Road Traffic Act, 1930, as amended, the effect of which will be to prohibit the driving of any vehicle the weight of which, whether laden or unladen, exceeds 2 tons on so much of the road leading from Ewerby Thorpe to the North Kyme—South Kyme Road (Route B. 1395) as is carried by Halfpenny Hatch Bridge over the River Slea in the Rural District of East Kesteven.

DEVELOPMENT ORDER, 1950.

NORFOLK COUNTY COUNCIL.

*Direction Restricting Permitted Development at
Sea Palling.*

NOTICE is given in accordance with paragraph (3) of Article 4 of the Town and Country Planning General Development Order, 1950, that the Minister of Housing and Local Government in pursuance of the powers conferred upon him by Article 4 of the said Order has approved a Direction made by the Norfolk County Council on the 16th January, 1957, relating to the following pieces of land at Sea Palling:—

(a) a narrow strip of land behind the Dunes, running South-eastwards from Mill Lane for a distance of approximately 330 yards, and

(b) a strip of land behind the dunes, running north-westwards from Beach Road for a distance of approximately 800 yards.

The effect of the Direction is to remove the following from the classes of "permitted development" set out in Part I of the First Schedule to the General Development Order, 1950:—

<i>Class Removed.</i>	<i>Description.</i>
I (1)	Certain development within a dwellinghouse (e.g. the enlargement, improvement or other alteration).
IV (2)	The use of land for the stationing of a caravan, or other moveable structure, for a period of not more than 28 days.
V	The use of land for the erection or placing of tents or caravans by members of recreational organisations holding a certificate of exemption granted under section 269 of the Public Health Act, 1936.

With effect from the date hereof, no development of the classes referred to above can be undertaken without specific planning permission.
