WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 12th day of December, 1957, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Supplementary Scheme which we have prepared with the consent of the Right Reverend Harold, Bishop of Saint Edmundsbury and Ipswich (in witness whereof he has signed this Scheme), for supplying an omission in a Scheme affirmed by an Order of Your Majesty in Council made on the 24th day of June, 1957, and published in the London Gazette on the 25th day of the same month (hereinafter called 'the original Order') for dealing with the benefices of Ingham with Culford and Timworth; Ampton with Little Livermere; West Stow with Wordwell; and Fornham Saint Martin with Fornham Saint Genevieve; all situate in the diocese of Saint Edmundsbury and Ipswich.

"SUPPLEMENTARY SCHEME.

"Whereas in pursuance of the original Order the benefice of Ampton with Little Livermere and a part of the benefice of Ingham with Culford and Timworth have become united under the style of the United Benefice of Ampton with Little Livermere and Ingham,' and the benefice of West Stow with Wordwell and a further part of the benefice of Ingham with Culford and Timworth have become united under the style of 'The United Benefice of Culford, West Stow and Wordwell':

"And whereas it was provided by clause 1 (3) of the original Order that, without prejudice to the exercise before the date of the union first hereinbefore mentioned of any of the powers conferred by the Parsonages Measures, 1938 and 1947, the parsonage house then belonging to the benefice of Ingham with Culford and Timworth (hereinafter called 'the said parsonage house') should, if at that date it so belonged to the said benefice, be the house of residence of the incumbent of the united benefice of Ampton with Little Livermere and Ingham:

of Ampton with Little Livermere and Ingham:

"And whereas it was our intention that in the event of the said parsonage house being sold before the date of the said union any site our glebe land in the parish of Ingham reserved for the erection of a new parsonage house together with such endowments of the benefice of Ingham with Culford and Timworth as represented the net proceeds of the sale of the said parsonage house and the net proceeds of the sale of any glebe land in the parish of Ingham sold therewith should be assigned and annexed to the united benefice of Ampton with

Little Livermere and Ingham; but no provision to that effect was made in the original Order:

"And whereas the said parsonage house and certain glebe land in the parish of Ingham were in fact sold before the date of the said union and a site was reserved on glebe land in the parish of Ingham for the erection of a new parsonage house and it appears to us that, contrary to our intention, the net proceeds of such sales and the said site reserved for the erection of a new parsonage house (which said endowments and property are more particularly specified in the Schedule hereto) now belong to the united benefice of Culford, West Stow and Wordwell by virtue of clause 4 of the original Order:

"Now, therefore, we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

"Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the endowments and property specfied in the Schedule hereto shall cease to belong to the united benefice of Culford, West Stow and Wordwell and shall be assigned and annexed to the united benefice of Ampton with Little Livermere and Ingham.

"THE SCHEDULE.

"(1) The land, being part of the enclosure numbered 102 on the ordnance survey map for the parish of Ingham, containing 0.75 of an acre or thereabouts which for the purpose of identification is shown verged blue on the map attached hereto together with all rights of way and other easements (if any) appurtenant thereto and subject to and with the benefit of the easements covenants and agreements in relation thereto granted reserved or contained in a conveyance dated the 31st day of May, 1957, and made between the Right Reverend Father in God Arthur Harold by Divine Permission Lord Bishop of Saint Edmundsbury and Ipswiich of the first part, the Church Commissioners for England of the second part and Charles Stennett of the third part.

"(3) The sum of £1,043 18s. 10d. representing the net proceeds of the sale under the Ecclesiastical Leasing Acts of 27 acres and 24 profes or thereabouts of glebe land in the parish of lingham belonging to the former benefice of Ingham with Culford and Timworth."
