REGULATIONS FOR THE RECRUITMENT OF OFFICERS OF CUSTOMS AND EXCISE IN THE CUSTOMS AND EXCISE DEPARTMENT.

- Men only are eligible.
- 2. No candidate may compete more than twice for the situation of Officer of Customs and Excise.

3. Age.
Candidates must be at least 18 and under 22 years of age on 1st March, 1958. But—

(a) a candidate who has served or is serving in H.M. Forces or H.M. Overseas Civil Service may deduct from his actual age the period of such service rendered before 1st March, 1958;
(b) a candidate who has served in any established post to which he was admitted with the Certificate of the Civil Service Commissioners may deduct from his actual age any time not exceeding two years which he has spent in such service before 1st March. 1958. 1st March, 1958.

4. Nationality.

B. Exemption from the written examination.

Candidates who possess, by the 6th March, 1958, one of the educational qualifications set out below will be exempted from the written examination.

(i) A General Certificate of Education, obtained in not more than two examinations, in English Language and four other distinct subjects; two of these must be at the Advanced level and obtained in the same examination. The four subjects must include a mathematical and a scientific subject at either Ordinary or Advanced level.

(ii) The Scottish Leaving Certificate with passes,

obtained in not more than two examinations, in English on the Higher grade and in four other subjects. Two of the passes other than English must be on the Higher grade. The four subjects must include science and mathematics. Passes in the Scottish Universities Preliminary Examination will be accepted as the equivalent of passes in the Scottish Leaving Certificate.

(iii) Passes equivalent to those in (i) obtained in

(iii) Passes equivalent to those in (i) obtained in not more than two sittings of the Grammar School Senior Certificate Examination of the Ministry

of Education for Northern Ireland. The subjects acceptable are those listed at (v) below. A candidate who has not been awarded the actual certificate should be prepared to produce the Ministry's certified statement of marks and of subjects passed, which may be obtained on application to the Ministry of Education, Netherleigh, Massey Avenue, Belifast.

The Selection Board will recommend to the Commissioners those candidates who appear to them to be most suitable for appointment.
