Casal, June 2. N. S. The Duke of Vendosme arrived here the 31st past from the French Camp in the Breician, having in his way higher viewed the Fortifications of several Towns in the Milanese and Monterrat. It is said, That he intends to continue here till the French Forces in these Parts are all arrived at Fontanella, the Place of their Rendezvous, and then to put himself at the head of them and march to Turin, and lay Siege to that Place; and after having given the necessary Orders for carrying it on, to leave the Direction thereof to the Duke de la Feuillade, and return into the Breician, in order to command that Army which is to make head against Prince Eugene. The Fortifications of Veceil being entirely demolished, the Cannon which was in that Town is brought hither, and planted upon our Walls. The French are erecting a great Magazine at Ivrea, for the Security of which the Count d'Estain is posted with a Body of 4000 Men at a small distance beyond that Place, as Monsieur Albergotti is on this side of it with another Body of French Troops.

Venice, June 6. The Abbot of Pomponne arrived here two days ago with the Character of Ambassador from the French King, and is preparing for his publick Entry and Audience. The Electors of Bavaria went lately from hence as far as the Borders of Carinthia, intending to have returned to Munich; but the Court of Vienna not judging it advisable to suffer her to come into Bavaria, there being Apprehensions at that time of an Insurrection in favour of the Elector, she came back the 31st past to Maestri, a Village about 5 Leagues distant from hence; and is since gone to Padua, where she designs to continue some time. The Germans who were in Garrison at Mirandola, and became Prisoners of War upon the Surrender of that Place, being about 400 Men, have lately been exchanged for a like number of French and Spanish Prisoners.

Rawitz, June 1. The King of Sweden is still here; but it is believed that his Majesty will shortly go to Elbing, near which Town all his Forces in Prussia are ordered to draw together. He has lately sent a Train of Artillery thither, with a considerable quantity of Ammunition. A Diet is now assembled at Proschowitz, in the Palatinate of Cracow, where many of the Nobility of Poland who are in the Interest of the new elected King Stanislaus are present; and it is said, that a Proposal will there be made about proceeding to his Coronation, of which we expect the Issue.

Cracow, June 4. N. S. The Diet which lately met at Proschowitz is adjourned to the 22d Instant. The Muscovite Forces in Lithuania are drawing together near the Weisell, with intent, as is believed, to make an Irruption into Poland; and the Swedes are making the necessary Preparations for opposing them. We hear that the Bishop of Lemberg, having been required to perform the Ceremony of Crowning the new elected King Stanislaus, excused himself, upon the Pope's absolute Commands to all the Clergy of this Kingdom not to concern themselves in it: Whereupon the Bishop is put under Arrest; but he persists in his Refusal.

Falmouth, June 11. Yesterday came in here the Wolfenbourg and the Young Gentleman, both Privateers belonging to Flushing, and with them the Two Brothers of London, John Pedy Master, laden with Sugar, Logwood and Indigo, from Jamaica: This Ship was taken on the 8th Instant by a French Privateer called the Good Friend of Morlaix, but was retaken the day following by the Dutch Privateers above mentioned, which likewise made Prize of the French Privateer. Yesterday also came in here from Pimouth Her Majesty's Ship the Triton Prize, commanded by Captain Miles.

Bristol, June 13. On the 10th Instant came in here from Jamaica the Sufannah, and yesterday the Happy-Return; both belonging to this Port, having been 8 weeks in their Passage: The Men on board them say, That they left that Island very healthy.

Tarmouth, June 15. A great Fleet of laden Colliers from Newcastle is now passing through our Road to the Southward, under Convoy of several of Her Majesty's Ships. The Solebay Man of War has lately brought in here as Prize a French Letter of Marque Ship, laden with Tar and other Goods from Norway, and bound for Dunkirk.
