WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of February, 1958, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Rawmarsh and Saint Thomas, Kilnhurst, both in the diocese of Sheffield.

"SCHEME.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Leslie, Bishop of Sheffield, consents to the proposed arrangements (in testimony whereof he has executed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Rawmarsh and Saint Thomas, Kilnhurst, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"The territory to be annexed to the parish of Rawmarsh:

say: "We, "We, the Church Commissioners acting in pursuance of the Pastoral Reorganisation Measure, 1949 and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend William, Bishop of Manchester (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Saimt Philip, Bradford Road, Manchester, the benefice of Saimt Mark, Holland Street, Newton Heath, and the benefice of Saimt Jude, Ancoats, Manchester, all situate in the diocese of Manchester.

- "1. Union of Benefices. The benefice of Saint Philip, Bradford Road, Manchester, the benefice of Saint Mark, Holland Street, Newton Heath, and the benefice of Saint Jude, Ancoats, Manchester, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Philip with Saint Mark, Manchester', and the parishes of the said benefices shall also be united into one parish for ecclesiastical nurposes. purposes.
- "2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the Union shall forthwith take effect and the Reverend James Barnes if he is then incumbent of the said benefice of Saint Philip, Bradford Road, Manchester, shall with his consent (which has been given to us in writing), be the first incumbent of the united benefice. benefice.
- "3. Parish Church. The parish church of the parish of Saint Philip, Bradford Road, Manchester. shall be the parish church of the united parish.
- "4. Registers. The marriage registers current at the churches of Saint Jude, Ancoats, Manchester, and Saint Mark, Holland Street, Newton Heath, shall and Saint Mark, Hohand Street, Newton Health, shall be dealt with in accordance with Section 62 of the Marriage Act, 1949, and the register books of baptisms and burials (if any) and other the records and muniments deposited in the said churches shall be transferred to the Church of Saint Philip, Bradford Road, Manchester.
- "5. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Saint Philip, Bradford Road, Manchester, shall be the house of residence of the incumbent of the united benefice, and the parsonage houses belonging to the benefices of Saint Mark, Holland Street, Newton Heath, and Saint Jude, Ancoats, Manchester, and the sites and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us at such time or times in such manner in all respects as to us shall seem expedient and the net proceeds of such sale or sales shall be placed to the credit of the Expenses Fund of the diocese of Manchester established pursuant to the said Union of Benefices Measures. - "6.—(1) Taking down of church. As soon as conveniently may be after the union has taken effect the Church of Saint Jude, Ancoats, Manchester, shall be taken down and the materials and site thereof together with any ground annexed thereto shall be sold by us, the said Church Commissioners.
- "(2) The furnishings of the said church of Saint Jude, Ancoats, Manchester, or so much of them as the Bishop of Manchester shall select, shall be removed to such other churches or chapels within
