#### The Savings Certificates (Amendment) Regulations, 1958.

The Regulations, which come into operation on 1st May, 1958, are to be published as a Statutory Instrument, 1958, No. 670. The Regulations raise the limit upon the maximum holding of the current issue of National Savings Certificates (Tenth Issue) by any one person from 600 unit certificates (purchase price £450) to 1,000 unit certificates (purchase price £750).

#### INTERNATIONAL ORGANISATIONS (IMMUNITIES AND PRIVILEGES) ACT, 1950.
