Our Will and Pleasure therefore is that you the said Bernard Marmaduke, Duke of Norfolk, to whom the cognizance of matters of this nature doth properly belong do see this Our Order kept and that you do cause the same to be recorded in Our College of Arms to the end that Our Officers of Arms and all others upon occasion may take full notice and have knowledge thereof.

And for so doing this shall be your Warrant. Given at Our Court at St. James's this twenty-first day of July, 1958, in the seventh year of Our Reign.
