## NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952 2nd September 1958.

To: AFRICA IMPEXPORT S.A. (AFRISA) Via Augusta 80, Barcelona, Spain.

Pursuant to section 275 (5) of the Customs and Excise Act, 1952 and paragraph I of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, to wit—two bales, marked "M. R. Hull," containing cotton and rayon blankets imported in s.s. "Alfonso" at Hull on 20th December 1956 have been seized as liable to for-feiture upon the grounds that the said goods were found not to correspond with the entry made thereof, because the entry declared that the value of the artificial silk component did not exceed 5 per cent. of the aggregate of the values of all the components,

of the aggregate of the values of all the components, when in fact the value of the artificial silk component exceeded such 5 per cent. Whereby and by force of section 44 (e) of the Customs and Excise Act, 1952 the said goods are liable to forfeiture. If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in (a) England who is authorised to accept service of process and to act on your behalf. In to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
