The City of Winchester (High Street) (Unilateral Waiting Restrictions) Order, 1958

The Winchester City Council propose to make an Order under the Road Traffic Act 1930, as amended, the effect of which will be to:—

• (a) vary the Order applying unilateral waiting restrictions to parts of High Street between 9 a.m. and 6.30 p.m. by extending the time limit for waiting from 15 minutes to 30 minutes in any one hour.

(b) revoke so much of the Order prohibiting waiting in parts of High Street between 9 a.m. and 6.30 p.m. as refers to the length between a point 13 feet west of its junction with Middle Brook Street and a point 30 feet east of its junction with Market Street.

Exceptions are provided to enable a vehicle to wait Exceptions are provided to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
