12. Allowances where Prolonged Abstention from Work is necessary following Approved Institutional Treatment.

"(A) Where it is certified that a member of the naval forces should on completion of a course of approved institutional treatment abstain from work for a prolonged period in consequence of the condition which necessitated that treatment, he may be treated as if he were eligible for a treatment allowance under Clause 11.

"(B) This Clause shall not apply to a member of the naval forces who is in receipt of an allowance under Clause 7 (a).

"13. Allowances for Part-time Treatment.

"Where a member of the naval forces receives treatment which would be approved treatment but for the fact that it involves only occasional interrup-tions of the member's normal employment, a employment, treatment allowance may be awarded to the member at such rate, not exceeding 40s. in respect of any one day (subject to a maximum payment of 65s. in

respect of any one week) as the Admiralty may think appropriate having regard to any loss of remunerative time by the member as a result of those interruptions. Provided that the rate of a treatment allowance awarded to a member under this Clause in respect of any period of a week or less shall not exceed the amount by which the weekly value of the member's existing award under Part I (excluding any award under Clauses 4, 5, 6, 7 (a), 8 or 10) falls short of the weekly value of the award which would have been appropriate in the case of that member under Clause 11 (excluding any award under paragraph (C) of that Clause) if he had been eligible for an award
