"4. Patronage. After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Castle Sowerby having the first presentation to the united benefice to be made after the union.

"5. Alteration of Boundaries, Upon the union taking effect the boundaries of the parishes of Sebergtaking effect the boundaries of the parishes of Sebergham, Caldbeck, Raughtonhead and Castle Sowerby shall, with the consents (which have been given to us in writing) of the Reverend Herbert Graham, the Reverend Robin Lang Wilson Jones and the Reverend Tom Lowther, incumbents of the benefices of Sebergham, Caldbeck and Raughtonhead respectively, be altered in the manner described in the Schedule to this Scheme.

"6. Archdeaconry and Rural Deanery. The united benefice shall be in the Archdeaconry of Carlisle and the rural deanery of Wigton.

"SCHEDULE

"1. Territories to be annexed to the parish of Caldbeck:

"(a) all that part (coloured pink on the map annexed hereto) of the parish of Sebergham which is bounded upon the south and west by the parish of Caldbeck and upon the remaining sides by an imaginary line commencing at the point on the boundary which divides the parish of Sebergham from the parish of Caldbeck in the middle of the road leading from Priest's Brow to Parkhead and proceeding thence north-eastwards and south-eastwards along the middle of the last mensouth-eastwards along the middle of the last mentioned road to its end and thence southwards in a straight line to the north-eastern corner of close 107 and thence generally southwards along the eastern boundary of close 107 and the western boundary of close 102 to the northern boundary of close 202 and thence eastwards and boundary of close 202 and thence eastwards along the northern and eastern boundaries of close 202 to the north-eastern boundary of close 111 and thence south-eastwards along the last mentioned boundary to its end and thence in the same straight line to and thence in the same straight line to the boundary which divides the parish of Sebergham from the parish of Caldbeck.

"(b) all that part (coloured green on the map annexed hereto) of the parish of Sebergham which annexed hereto) of the parish of Sepergnam which lies to the south of an imaginary line following the middle of the River Caldew from a point opposite the middle of the eastern end of Cald Beck to the boundary between the parish of Sebergham and the parish of Castle Sowerby.

"2. Territories to be annexed to the parish of

Sebergham:

(a) all that part (coloured purple on the map annexed hereto) of the parish of Raughtonhead which is bounded upon the north-west by the parish of Sebergham on the south-west, south and east by the parish of Castle Sowerby and upon the remaining sides by an imaginary line com-mencing at the point on the boundary which divides the parish of Castle Sowerby from the parish of Raughtonhead in the middle of the road which leads from Cockleygill Bridge to Corpse Cross and proceeding thence north-west-wards along the middle of the last mentioned road to its junction with the road which leads from Corpse Cross to Bustabeck Bridge and thence south-westwards along the middle of the last mentioned road to the middle of Bustabeck Bridge which carries the last mentioned road over Busta Beck and thence north-westwards over Busta Beck and thence north-westwards to and along the middle of Busta Beck to the point where it meets the boundary which divides the parish of Raughtonhead from the parish of Sebergham.

"(b) all that part (coloured brown on the map annexed hereto) of the parish of Castle Sowerby which is bounded upon the west by the parish of Sebergham on the parts and poeth each by the

Sebergham on the north and north-east by the parish of Raughtonhead and upon the remaining sides by an imaginary line commencing at the point on the boundary which divides the parish of Castle Sowerby from the parish of Raughtonhead in the middle of the road which leads from Limekiln Nook Cottage to Cowgill and proceeding thence south-westwards and westwards along the middle of the last mentioned road to a point opposite the south-eastern end of the south-western boundary of roadway close 560 and thence north-westwards to and along the last mentioned boundary to its end and thence

generally north-westwards along the south-western boundary of close 562 to its end and thence in the same straight line to the boundary which divides the parish of Castle Sowerby from the parish of Sebergham."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganition Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 14th day of August 1958, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, the Union of Benefices Measures, 1923 to 1952, and the Diocesan Stipends Funds Measure, 1953, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the following Scheme which we have prepared with the consent of the Right Reverend Robert, Bishop of Peterborough (in witness whereof he has signed this Scheme), for effecting the union of the benefice of Cranford and the benefice of Grafton Underwood, both situate in the diocese of Peterborough.

- "1. Union of Benefices. The benefice of Cranford and the benefice of Grafton Underwood shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Cranford with Grafton Underwood' but the parishes of the said benefices shall continue in all respects distinct.
- "2. Taking effect of union. If upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the benefice of Grafton Underwood shall be vacant the union shall forthwith take effect, but if it shall then be full the union shall take effect upon the next avoidance thereof.
- "3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Cranford shall be the house of residence of the incumbent of the united benefice.
- "4. Patronage. After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Cranford having the first presentation to the united benefice to be mede after the union. be made after the union.
 - "5. Diversion of Endowment Income
 - "(1) Subject as hereinafter provided, any surplus, calculated by us for the twelve months ending on the 31st March in each year, of the endowment income (calculated in accordance with the Schedule hereto) of the united benefice over and above an annual sum of £750 shall, with effect from the date upon which the union shall take effect, be paid to and be held by us, for the benefit of the diocesan stipends fund of the said diocese.
 - "(2) The said endowment income and the said surplus and the said annual sum of £750 shall be deemed to accrue from day to day and shall when we deem that circumstances so require be apportionable accordingly.
 - "(3) Any moneys due to us from the incumbent of the united benefice, or, during any vacancy in the united benefice, from the sequestrators thereof, as the case may be (hereinafter called 'the incumbent or sequestrators') upon the calculation of the said surplus shall be paid by the incumbent or sequestrators to us not later than the 30th June in each year and shall be recoverable as a debt due to us. to us.
