The QUEEN'S Most Excellent Majesty in Council Whereas the Minister of Housing and Local Govern-Whereas the Minister of Housing and Local Govern-ment, after giving 10 days' previous notice of his intention in that behalf, did, under the provisions of the Burial Act, 1853 (16 & 17 Vict. c. 134), as amended by subsequent enactments, make a Repre-sentation to Her Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Aldeby, in the County of Norfolk, save with the previous approval of the Minister of Housing and Local Government, should be prohibited, and that burials Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some con-spicuous places within, the Parish affected by such Representation one month before the said 15th day of December. 
