#### FOOD AND DRUGS ACT, 1955

##### CITY OF CARDIFF

###### *The City of Cardiff (Food) Declaration, 1958*

Notice is hereby given that on the 27th November 1958, the Minister of Health made the City of Cardiff (Food) Declaration, 1958, the effect of which is to bring into force in the city of Cardiff on the 1st January 1959, subsection (1) of section 16 of the Food and Drugs Act, 1955, which requires the registration with the local authority of premises used for (a) the sale, or the manufacture for the purpose of sale, of ice-cream, or the storage of ice-cream intended for sale, or (b) the preparation or manufacture of sausages or potted, pressed, pickled or preserved food intended for sale.
