COUNTY OF CORNWALL Regulation of Traffic Launceston Borough

The County Council of the Administrative County of Cornwall propose to make an Order under the Road Traffic Act, 1930, as amended, the effect of which will be that:

1. No person shall drive or cause or permit to be driven any vehicle on any of the lengths of road specified in the first column of the First Schedule hereto otherwise than in the direction specified opposite to such length in the second column of the said Schedule.

2. No person shall except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to wait in any of the lengths of road specified in the Second Schedule hereto.

3. No person shall except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to wait between the hours of 9 a.m. and 6 p.m. daily in any of the lengths of road specified in the Third Schedule hereto.

4. Exceptions will be provided in the Order to allow a vehicle to wait in any of the lengths of road referred to in paragraphs 2 and 3 hereof, for so long as may be necessary:

(a) to enable a person to board or alight from the vehicle;

- (b) to enable goods to be loaded on to or unloaded from the vehicle;
- (c) to enable the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building opera-tion or demolition, the removal of any obstruc-tion to traffic, the maintenance, repair or improve-ment of the roads or the services therein;
- (d) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road; (e) in connection with a funeral.

- Western Road (A.3048)-on the south-east side, from its junction with Broad Street for a distance of 22 yards in a south-westerly direction.
