Notice is hereby given that on the 23rd March 1959, the Minister of Transport and Civil Aviation made "The Trunk Road (Tamworth Road Long Eaton) (Unilateral Waiting) Order, 1959" which will come into operation on 13th April 1959. The effect of the Order is that with certain exceptions, no person shall cause or permit any vehicle to wait between 8 a.m. and 8 p.m. in that length of the North East of Birmingham—Nottingham Trunk Road (Route A.453) at Long Eaton known as Tamworth Road which lies between its junction with Market Place and its junction with Broad Street:

- (a) on the east side on even dates ;
- (b) on the west side on odd dates ;
- (c) on that side on which vehicles are not for the time being prohibited from waiting by (a) or (b) above—
 - (i) for a longer period than thirty minutes ; or
 - (ii) if a period of less than thirty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side.
