The Post-War Credit (Income Tax) Regulations,

These Regulations prescribe the qualifications to receive repayment of Post-War Credits.

The classes who qualify are set out in Regulation

3 and are:

- (1) Age: men aged 63 or over and women aged 58
- or over; (2) Death: ) Death: the personal representatives or beneficiaries of Credit holders who have died; or

(3) Hardship:

(a) persons who for a continuous period of 12 weeks ending after 7th April 1959, have been receiving National Assistance;
(b) persons who, after 7th April 1959, are persons named in a register of blind persons required under statute to be kept by a local authority;

(c) persons who, after 7th April 1959, are receiving constant attendance allowance or unemployability supplement under the War Pensions Instruments, the Industrial Diseases (Benefit) Acts, or who would have been in receipt of unemployability supplement if they had not claimed an alternative benefit, or would have been in receipt of constant attendance allowance but for being a hospital

In the hardship cases the responsible authority, as defined in Regulation 2 (3), will certify the facts on

defined in Regulation 2 (3), win certify the facts of which the claim is based.

Regulation 5 provides that the trustee in bank-ruptcy may claim repayment of a Credit when the bankrupt would have been qualified to receive repayment had he not become bankrupt. This preserves the law which has been in force since 1954.

Regulation 6 lays down certain requirements for regiving applications for repayment of Credits.

An Inquisition indented, taken for our Sovereign Lady the Queen, at H.M. Prison, Pentonville, pursuant to the directions of "The Capital Punishment Amendment Act, 1868," on the twenty-eighth day of April, in the year of our Lord one thousand nine hundred and fifty-nine, before Sir W. Bentley Purchase Coroner of our said Lady the Queen for the said County of London on view of the body of Joseph Chrimes now here lying dead at Her Majesty's Prison, Pentonville within the Jurisdiction of the said Coroner, upon the oaths of the undersigned Jurors, good and lawful men of the said County of London, who being now here duly chosen, sworn, and charged to enquire, for our said Lady the Queen, when, where, and in what manner, the said Joseph Chrimes came to his death, say upon their oaths that the said Joseph Chrimes was a Prisoner in the said Prison, indicted and convicted for the murder of Norah Summerfield and sentenced to death for the said offence, after the passing of the said Statute. And that Judgment of death was duly executed and carried into effect upon the said offence, on the day and year affected within the wells of the said Prison in offender, for the said offence, on the day and year aforesaid, within the walls of the said Prison in

which the said offender was confined at the time of execution. And the Jurors aforesaid, upon their oaths aforesaid, do further say that this Inquest is now here held, on view of the body of the said offender, by the Coroner of the Jurisdiction to which the said Prison belongs, within twenty-four hours after the execution; and that the body of the said Joseph Chrimes now here lying dead, is the identical body of the said offender, who was so convicted and executed for the offence aforesaid. And that the said offender, at the time of his death was a male person, of the age of thirty years, and a labourer.
