And the Petitioner the said Clara Bourne by her Counsel undertaking to take all steps necessary for procuring that the said Company be speedily placed in Voluntary Liquidation

And it was ordered that the Petitioners the said Perran Bay Hotel, Limited Clara Bourne and Charles Edgar Ware do pay to the Registrar of Companies his costs of the said Petition such costs to be taxed

The Talke—Balterley Heath Trunk Road

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under section 1 of the Trunk Roads Act, 1946, as extended by section 14 of the Special Roads Act, 1949, the effect of which is that a new road which he proposes to construct between a point near Talke in the County of Stafford and a point in the County of Chester near

Balterley Heath will become a trunk road on the date when the Order comes into operation.
