EMERGENCY LIST

The Royal Warrant of 19th February 1954, modifying the conditions of service of certain air force officers has been amended by a Royal Warrant dated 29th June 1959, and, with effect from 1st July 1959, all male officers on the Royal Air Force Emergency List who :

(a) served with the air forces at any time during the period beginning 3rd September 1939, and ending 31st December 1948, and who were released from such service in accordance with the Regulations for the Release of R.A.F. Personnel under the Order made by His Late Majesty King George VI dated 22nd August 1945, or

(b) were appointed before 1st January 1949, to short service commissions in the Royal Air Force and completed before 1st July 1959, the period of regular and reserve service for which they were appointed,

are released from their liability for recall to the Service and will relinquish their commissions.

Officers who are or have been liable under the National Service Acts, 1948 to 1955, and who before 1st July 1964, complete periods of service equivalent to the periods of whole-time and part-time service imposed by these Acts will continue to hold their commissions on the Royal Air Force Emergency List and retain a recall liability under the Royal Warrant of 29th June 1959, until 30th June 1964, or until the age of 45 whichever is the earlier.
