Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Alan William Harrison if he is then incumbent of the said benefice of Somerby and Burrough on the Hill shall, with his consent (which has been given to us in writing), be the first incumbent of the united benefice benefice.

"3. Parsonage House.
